# WHAT'S NEW?

This topic lists features that are new or changed for eftsure inside Dynamics 365 for Finance and Operations.

This document contains the release notes for the very latest version of eftsure inside Dynamics 365 for Finance and Operations, currently available in LCS. We only maintain one version on LCS at all times.

Use these notes to check for new features based on your specific version.

Our versioning follows a specific pattern:

[MajorVersion].[Build].[Preview].[Changeset]

**Major Version:** Major version number (1 for AX2012, 2 for D365, 3 for D365UI, 4 for International)

**Build:** Build server platform update – Minimum platform update, deployment will not work below this update version.

**Preview:** Dev server platform update – Maximum Preview Version used for dev/test, higher platform update are not available at time of release, use at your own risk on higher platform updates.

**Changeset:** DevOps changeset number, used to track historical code changes.

**For example:**

Version x.**38.40**.yyyy:

is valid for D365 release 10.0.**38**, 10.0.39, 10.0.**40**,

hasn't been tested against 10.0.**37** and **below**,

hasn't been tested against 10.0.**41** and **above**.
